Plaint be registered as a suit. Issue summons in the suit to the defendants by ordinary process and speed post, returnable on 22.01.2019.

IA No.15492/2018

By this application plaintiff seeks ad interim injunction of stay on the conduct of election process and ex parte injunction directing defendant No.1 to include the names submitted by the plaintiffs as their respective representatives for constituting a proper electoral college.

The case of the plaintiff is that elections are being held to defendant

Court Master High Court of Delhi New Delhi

No.1/Federation. On 4.11.2018 defendant No.4 on behalf of defendant No.1 published the list of Electoral College in respect of the elections to be conducted on 18.11.2018 but arbitrarily excluded the names of peveral candidates including the names of the representatives of the plaintiffs. It is pleaded that this has been done arbitrarily and there is no basis or ground to exclude the said representatives of the plaintiffs nor any reason has been communicated to the plaintiffs.

Issue notice to the defendants by ordinary process and speed post, returnable for the date fixed above.

In the meantime, the elections be held on 18.11.2018. The representative of the plaintiffs shall be allowed to caste their votes separately which shall be kept in a sealed cover. It is also clarified that the result of the elections shall be subject to further orders that may be passed by this court.

Plaintiff to comply with provisions of Order 39 Rule 3 CPC within three days. Defendants No.1 and 7 will ensure that the complete record of the elections including the electoral list, ballet papers are duly preserved and kept in a sealed cover for scrutiny of the court, if so required.

A copy of the order be given Dasti under signatures of the Court Master, as prayed for.
